### About the Pandemic Treaty

At the World Health Assembly (WHA), the 194 members of the WHO have adopted on 31 May 2021 the decision to discuss a new international treaty on pandemics at a special session to be held in November 2021. The WHA adopted a decision to support the launch of negotiations for an international treaty on the fight against pandemics within the framework of WHO.

Such a treaty would support international efforts to reinforce global health security, in particular on preparedness and response to health emergencies, in light of lessons learnt from the pandemic. Experts from around the globe will be discussing the Pandemic Treaty and its associated aspects in this webinar organized by the Department of Global Health, Stellenbosch University, South Africa.
